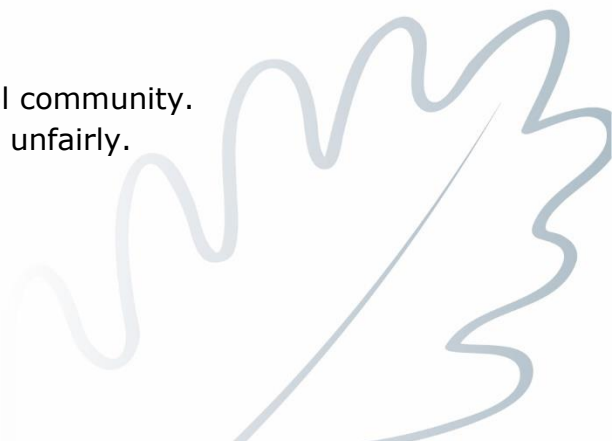
Our pupils are taught to be:
